To nominate a candidate to serve on the Board of Trustees, the form below must be filled out by the nominator and the candidate. Directions for filling the form are attached. The form may be emailed, mailed or provided when registering at the AGM.

## **Directions for filling out the Nomination form:**

Anyone qualified to vote in the Hagensborg Waterworks general election can nominate a qualified Candidate to fill a vacant position as Trustee in a General Election. To qualify to nominate a Candidate under the Provincial Elections Act, you must be a Canadian Citizen, eighteen years or older on Voting Day, a resident in the Province for at least six months before Voting Day, and an owner (or the spouse or legal representative of the owner) of land within the boundaries of Hagensborg Waterworks District.

### To nominate a candidate: Download and print the document

1. Fill in your first and last name and your civic address.
2. Fill in the first and last name of the person you are nominating, and their civic address.
3. Check which position you are nominating them for. You may nominate them for one, two or all three positions.
4. Confirm your understanding of their qualification to stand as candidate for the position of Trustee by filling in their name again.
5. Sign where indicated and neatly print your name.

Provide the form to your Candidate.

### To accept nomination for a Trustees position:

6. Print your first and last name where indicated as Candidate.
7. Select the position by that term you are accepting nomination for. You may accept the nomination for any and all positions you are nominated for. You may not accept a position you are not nominated for.
8. Enter your civic address of property you or your spouse owns within the boundaries of the Hagensborg Waterworks District, or
9. If you are the legal authorized agent for a Board or Corporation owning land within the boundaries of the District, enter the registered owners name and the civic address of the property owned within the boundaries of the Hagensborg Waterworks District.
10. Sign the form agreeing to the nomination and declaring you are not disqualified under any other Regulation or Acts.
